

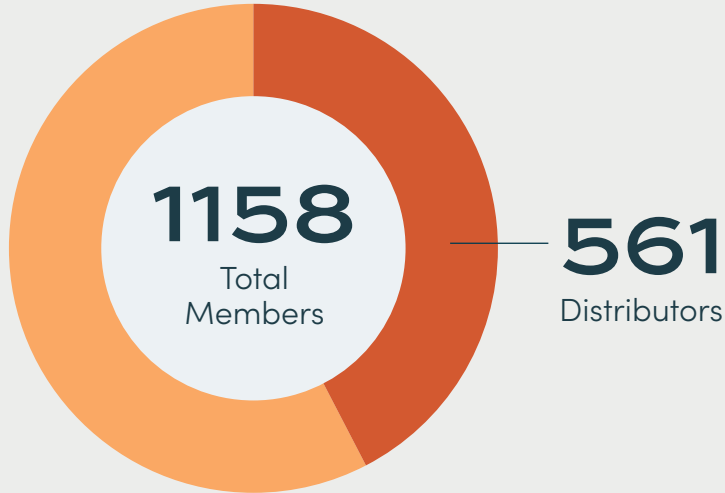

Corporate Transparency Act Still Suspended Despite Supreme Court Ruling

Last week, the U.S. Supreme Court reversed an injunction stemming from *Texas Top Cap Shop Inc. v. McHenry*, one of two major court cases challenging the Corporate Transparency Act. While the Supreme Court undid this injunction, a second injunction remains in place and stems from the *Smith v. U.S. Dept. of Treasury* case from a different federal court judge. This means a nationwide injunction is still in effect, and no companies are required to submit beneficial ownership information to **FinCEN** (Finance Crimes Enforcement Network).

Due to the uncertainty caused by the back-and-forth between courts, HARDI supports the Repealing Big Brother Overreach Act introduced by Senator Tommy Tuberville (R-AL) and Representative Warren Davidson (R-OH). HARDI signed a [coalition letter](#) supporting this legislation and urging Congress to provide certainty to businesses nationwide.

Last week, the U.S. Supreme Court reversed an injunction stemming from Texas Tap Corp. Inc. v. Morheny, one of two major court cases challenging the Corporate Transparency Act (CTA). While the Supreme Court upheld the injunction, it also affirmed the U.S. Dept. of Treasury's view from a different federal court judge. This means a nationwide injunction is still in effect, and no companies are required to submit beneficial ownership information to FinCEN (Financial Crimes Enforcement Network).

Due to the uncertainty caused by the back-and-forth between courts, HARDI supports the Rescinding Big Brother Corporate Act introduced by Senator Tommy Tuberville (R-Ala.) and Representative Warren Davidson (R-Ga.). HARDI signed a [coalition letter](#) supporting this legislation and urging Congress to provide certainty to business nationwide.

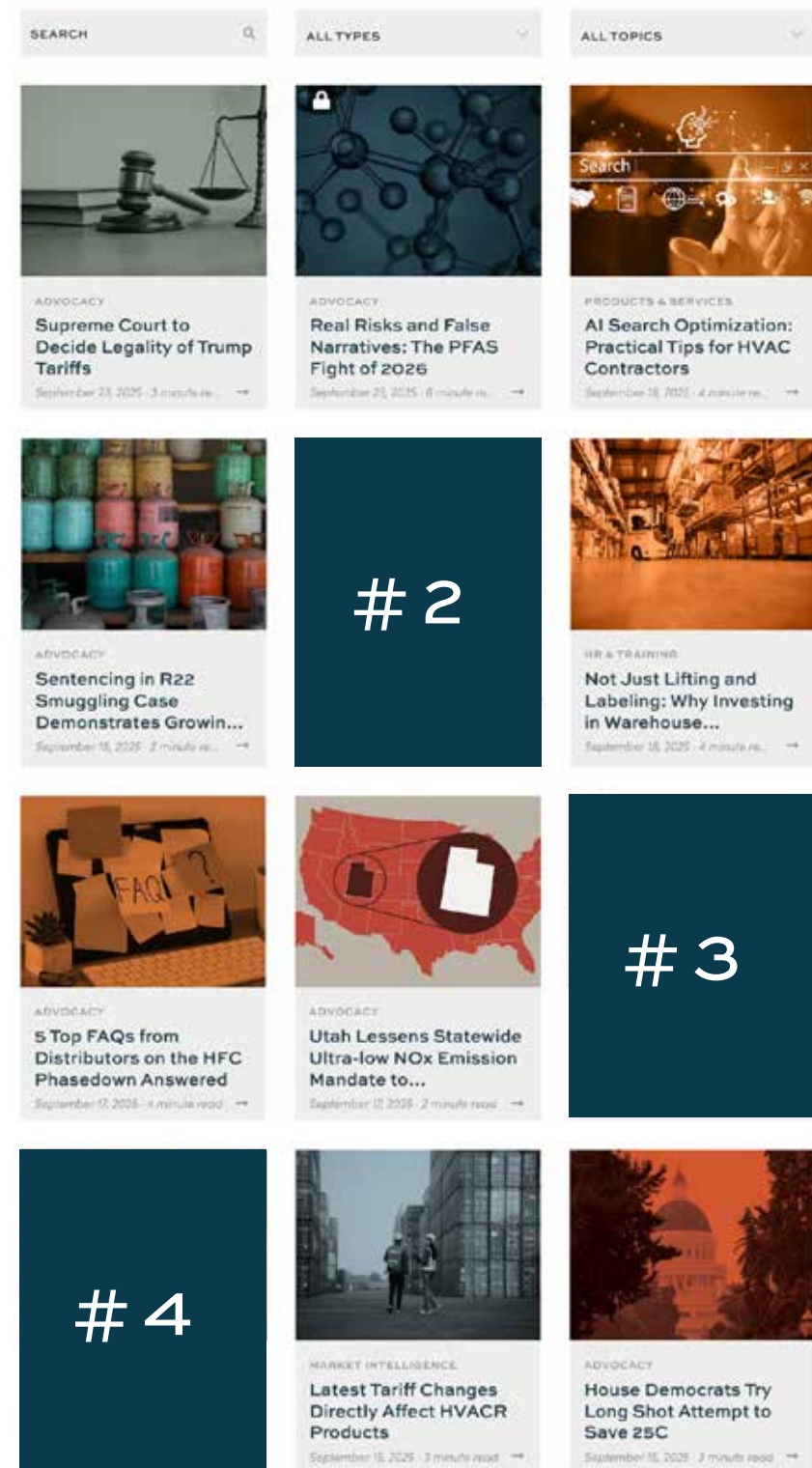

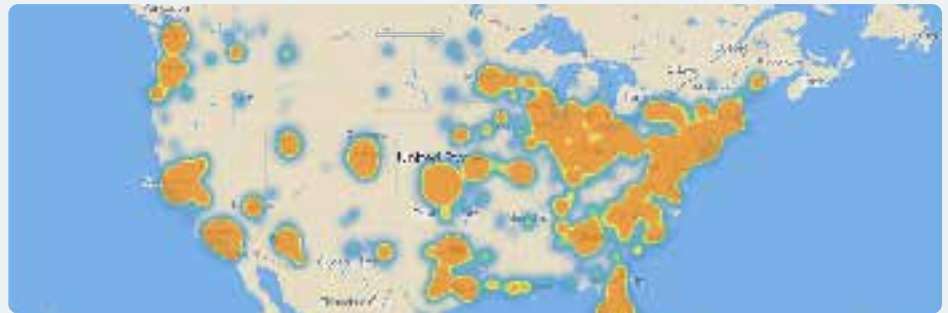
